GENERAL SESSION MINUTES

 - Board Chairman Steve Turcotte called the meeting to order at 6:00 pm.

Call to the Public.

Consideration and discussion of comments and complaints from the public. Those wishing to address the Pinal Rural Fire Rescue/Medical Board need not request permission in advance but their time is limited to 3 minutes. The Fire District Board is not permitted to discuss or take action on any item raised in the call to the public. However, individual Board members may be permitted to respond to criticism directed to them. Otherwise, the Board may direct that staff review the matter or that the matter be placed on a future agenda. The Fire District Board cannot discuss or take legal action on any issue raised during the Call to the Public due to restrictions of the Open Meeting Law.

- 6. Financial Report Chairman Turcotte discussed the various account balances. He indicated that the District has collected all but 30% of the taxes. He also indicated that the staff will be working on the budget for nest fiscal year and that last years budget was on track for Execution.
- 7. Chief's Report- Chief Apodaca discussed the donation we received from Saddlebrook, elaborate gas detectors for the corridor since there are none, still working on grants. 1st net to pay for equipment for 3 years and then we will keep it but don't have to pay if we aren't satisfied. We are at 24 calls for the year.
